



EXHIBITING COMPANIES RULES OF CONDUCT

Thank you for choosing to exhibit at the 2016 AVN Adult Entertainment Expo (AEE) & the AVN Novelty Expo (ANE). As the organizer AVN Media Network is required to comply with the laws of the states in which AVN holds its events. By exhibiting in any of the Shows and signing this document, the Exhibitor identified below, on its own behalf and on behalf of its employees, agents, talent and independent contractors, agrees to comply with the specific conduct limitations set forth below (the "Rules of Conduct") applicable to any adult entertainment performances, products or services featured, incorporated or included in any aspect of Exhibitor's participation in AEE/ANE.

The Exhibitor identified below is hereby notified that conduct at AEE/ANE which violates the Rules of Conduct will not be tolerated. **The Rules of Conduct will be strictly enforced on a zero tolerance basis. Any Exhibitor violating the Rules of Conduct WILL BE IMMEDIATELY SHUT DOWN AND WILL BE SUBJECT TO A FINE OF UP TO \$1,000.00 PER VIOLATION.**

THE RULES OF "LIVE" CONDUCT ARE AS FOLLOWS:

- No nudity of any kind on the show floor, registration, lobbies, special events, meeting rooms and/or seminar rooms, including but not limited to exposure of genitalia or female breasts (areola or nipples), pubic hair, cleft of buttocks or an us
- No sexual contact or behavior (real or simulated), including, but not limited to penetration of any kind, simulated sex of any kind, or fondling of breasts (whether or not covered), buttocks or genitals, no lap dancing
- No ejaculation, defecation, urination, lactation or any presence of any bodily fluids
- All individuals must be properly clothed. Sheer or otherwise transparent garments are not acceptable forms of dress on the show floor. Nipples, genitalia and the buttocks must be covered at all times. No flashing.
- No smoking anywhere on the show floor, registration, lobbies, special events, meeting rooms and/or seminar rooms

THE DEPICTION OF THE FOLLOWING IN ANY FORM (IN PERSON, ELECTRONICALLY OR ON ANY PRODUCT) IS PROHIBITED AT THE SHOWS:

- Any type of sexual penetration, including fellatio, cunnilingus, digital penetration, vaginal or a nal penetration of any kind. Penetration of any kind may not be shown.
- Pedophilia including videos, films or graphic images that involve or suggest any kind of pedophilia
- Nudity involving individuals under the age of 18 years
- Any sexual conduct with animals
- Fisting
- Snuff movies
- Ejaculation, defecation, urination, lactation or emission of other bodily fluids

DEMONSTRATIONS

Exhibitors may demonstrate product within their exhibit space provided that:

- Demonstrations include products manufactured or distributed by the exhibitor.
- Amplified demonstrations do not exceed **75 decibels**.
- Demonstrations do not exceed 5 minutes in duration.
- Demonstration is for a potential buyer and not merely to attract attention.
- Aisle in front of booth must be completely clear from obstruction.
- All show "Rules of Conduct" apply when doing any type of demonstrations.

PLEASE NOTE: No DJs will be permitted in booths at anytime. Show management will provide an official show DJ in all exhibit areas.
